The grants received were higher than expected. Overall the Transportation budget deficit is approximately \$500,000 and continues to be of significant concern to the Board. Brandt to start looking into costs for another 7 new buses as part of the fleet renewal plan for next school year. S. Russell will provide information on cost to the Transportation committee.
