Transportation Quarterly Report

Associate Superintendent Corporate Services S. Russell presented the Transportation Quarterly Update.

- The 2020/21 budget report was presented for review.
- The estimated expenses for the 2020/21 budget are \$7,057,944.00 with a shortfall of (155,169.03). Six new buses are accounted for in the expenses.
- Transportation has purchased five used 82 passenger buses and a 2015 min bus and is in the process of purchasing another mini bus.
- Chinook's Edge has ordered seven buses which will arrive after September 1, 2021 in order to have them paid for out of the 2021-2022 budget.
- Approximately \$475,000.00 has been allocated to cameras, new radios and GPS for the fleet.

Trustee S. Cooper asked if there are any urban bus routes that are of concern for ride times. S. Russell shared that all urban routes are with the required ride times.

Trustee T. James shared that this is a good group! Even though the Board can disagree on things we come away positive. Chair and Vice Chair have done an amazing job.

Trustee J. Knispel-Matejka shared that considering the circumstances this year went well. The Board accomplished a lot this year. The Chair and Vice Chair worked well together.

Trustee C. Huelsman shared that the Board did a great job working together this year.

Trustee G. Kerr shared that the Board worked extremely well together and stayed focused on students and what is best for them. The Chair and Vice Chair did a great job this year.

Trustee M. Copley enjoyed the new learning this year. Enjoyed diving into the Board evaluation.

Trustee H. Bilton shared a thank you with Trustees for how well they work together. She also noted that it was a huge learning curve this year.

K. Sacher shared that it is so important for the success of the school division to have a high functioning Board and we have that.

Third Quarter Financial Report (September 1st to May 31st)

Treasurer S. Roy presented the 3rd quarter financial report (September 1, 2020 to May 31, 2021) highlighting the following:

Treasurer S. Roy presented the 3rd quarter financial report (September 1, 2020 to May 31, 2021) highlighting the following:

Revenue:

- Includes \$3.9 million of Pandemic Funding that was previously listed under the Federal Government. Includes \$2.5 million of CMT funds that will be capitalized and \$2.4 million of IMR funds of which \$1 million will be capitalized. Three months of ATRF to come (\$1.5 million). \$1.2 million funding adjustment mitigated.
- Instruction resources fees: swim fees are 32% of instruction fees and we did not have those this year. Instructional fees are around 90%.

- Transportation Fees: collections are still going on.
- Fundraising: will be recorded when received, \$433,740 represents fundraising from SGF not spent.
- Other: Represents funds received from municipalities for FCSS and other grants received (other grants recorded as received).
- Amortization of capital allocations: Recorded in March and August.

Expenses:

- Certificated salaries: Paid over 12 months, last June it was 73.5%, some sick leave covered by federal one-time funding.
- Certificated benefits: CPP and EI began again in January and is on track, last June it was 75.3%.
- Non-certified salaries and wages: Critical Worker Benefit \$748 thousand, EA's, bus drivers, daytime custodians paid over 10 months, vacation pay is accrued as earned. Last June was 78.4%.
- Non-certified benefits: coming in a bit lower.
- Services, contract and supplies: Last June was 81.4%. No extracurricular activities for the first 8 months of the year.
- Amortization: Recorded in March and August.

S. Roy also highlighted the following:

- Budget reports for all schools and non-schools.
- Remote learning federal funding budget is on track.
- School generated funds will be higher than previous years as activities did not happen.
- Pandemic costs to May 31st and there may be additional costs coded to this budget.
