- The committee chairs will be selected by the entire Board according to the same rules used to select the Chair, Vice Chair.

Trustee discussed committee alternates attending meetings as it is a good opportunity to learn. Common practice in other organizations is for the alternate to attend meetings for the first year. Alternates would not have a vote at committee meetings unless they are attending on behalf of a member. The Board of Trustees supports this for the 2021/2022 year.
