2nd Quarter Financial Report (September 1 to February 28th)

Treasurer S. Kaiser joined the meeting to present the 2nd Quarter Financial Report (September 1st to February 28th).

- S. Kaiser highlighted the following:
 - Overall budget looks good.
 - Watching substitute teacher pay as it is quite high and was just about at budgeted amount by the end of February and more subs are expected until the end of June.
 - It has been suggested to schools to buy materials required now instead of waiting.
 - In 2023 there will be a restriction on operating reserves. Projections will be very important.
 - It was noted that the CLC (Community Learning Campus) money the
 division gets for PO&M (Plant Operations and Maintenance) is given to
 CLC and then Olds College puts that money into a budget line. All
 expenses come out of the budget line and at the end of every year
 there is a surplus or deficit. Right now there is a surplus and Olds
 College holds that money and gives the division interest on this
 money.

Budget Update - 2022/2023

Treasurer S. Kaiser provided an update on budget 2022/2023. She noted that there were no surprises in the budget. The increase in transportation of 4.6% will help cover the increased costs to fuel and insurance. There was a 1% increase to operations and maintenance and some slight growth in enrolment increases. Budget will be similar to last year even though it appears there are increases because of the increase in costs. There will be an increase in cost for teachers due to grid creep and ASEBP and CPP increases. At this time, it is not known what the increase to EI will be. The budget will be released to schools next week and will come back to the Board on May 25th.

Trustee Quarterly Remuneration Report (to February 28th)

The trustee quarterly remuneration report was provided for review. It was noted that February costs do look higher as there was no travel for the previous two years.

Superintendent Quarterly Expenses (to February 28th)
