High School Completion Results

Highlights:

Key Strategies and next steps:

- CRM structure will continue to play an important role in supporting our at-risk students. Having our Career Highs linked with the high schools gives them the ability to student students right away.
- Continued focus on blending our at-risk students in alternative learning with traditional high school practices.
- Career Practitioners / teams in schools key role as students enter into grade 9.
- Dual credit opportunities (98% graduation rate).
- Work-embedded learning opportunities (Industry partnerships).

Trustees provided the following questions and comments:

- As each school has a career practitioner, do they identify the at risk students? J. Drent shared that Administrators identify the students and the career practitioner is involved in finding a solution.
- Love the grade 13 and 14 innovative pathway opportunity.
- What is the funding for grade 13 and 14? J. Drent shared that the allocation is 50% per student in grade 13 and 25% in grade 14.
- Is the focus to help students that are struggling to get them back in the classroom? J. Drent shared that the highest level of success is in the classroom. Career highs have the opportunities to provide that instruction.
- J. Drent noted that literacy target information will be on the dashboard.

Summer School Report

Associate Superintendent Learning Services J. Drent and Associate Superintendent People Services R. Hoppins shared the 2022 Summer School Summary which included site details and a total for 341 students enrolled. Total CEU's for 2022: 1155 funded CEU's. 11 diploma exams written.

Trustees provided the following questions and comments:

- Does the division know who is attending and from which areas of the division?
- How would the Board see the connection to learning?
- We see the growth over the years as the numbers are going up.

R. Hoppins shared the following: Traditionally the division has three locations. Staffing summer school is challenging at times. The in-person learning, results in higher success rates. We do not have the stats on where students reside but will get that information. Sometimes it depends on where the students want to attend. The growing trend is students doing catch up as they may have lost their way during Covid.

Important to remember the challenge is that a typical course is 125 hours and summer school runs 80 hours.

A trustee shared that some students cannot get to the location where summer school is being offered. We need to challenge the conversation that summer school cannot be done differently. This expectation people have is different and this should be looked at as alternative learning. Accessibility needs to be there for all students. Summer school is no longer about students that need to catch up as there are many different reasons to attend summer school.

Post-secondary is changing and offering in-person and online courses. The idea of anytime anywhere.

Superintendent Sacher would like some time to work with his team to look at options to bring to the Board.
