## Full Time Family Enrichment Workers

### **Responsibilities include but are not limited to:**

- Coaching/mentoring parents
- Mental Health Intervention with parents and children (6 – 18 yrs.)
- Linking families with community services
- Family support and advocacy
- Facilitating Family Network Meetings
- Working as a member of a multiple disciplinary professional team
- In Home Family Assessment and Intervention

### **Minimum Qualifications and Requirements:**

- Degree in the Human Services Field and minimum 5 years human services experience (consideration will be given to those with diplomas and 10+ years of experience)

- Have the ability to model appropriate parenting skills

- Knowledge and experience within the Signs of Safety framework considered an asset
