 For the 2022-23 school year the main three goals are the collaborative response processes, staff learning and high school collaboration.

Trustees discussed approving collaborative days and wonder if going forward they should just approve the school calendar. It was noted that in the spring this topic should be discussed further as this could become an embedded practice.

Reporting on collaborative days could be part of the data dashboard which will demonstrate that collaborative days are being utilized effectively.
