## **ASBA Budget and Bylaws Bulletin**

The Board of Trustees reviewed the background information for the ASBA Budget the Bylaws Bulletin.

Budget: A 2.5% membership fee increase was proposed and supported, in line with long-term reserve strategy. Discussion included member trust in the Board of Directors and prior motions affirming a gradual increase plan.

Bylaw Amendments: Key updates included removal of alternate directors and clarification of closed session procedures. The Board expressed support.

Emergent Resolution (Transportation Distance): Board expressed concern that the proposed resolution inaccurately specified a 1.0 km walk limit for elementary students only. Chinook's Edge confirmed their position is to advocate for a 1.6 km walk limit for all students.

The Board discussed ASBA's proposed advocacy to ensure school boards receive fair market value for land transfers. Discussion noted current provincial direction to transfer all future school titles to Alberta Infrastructure, with leases back to boards.

The Board agreed with the resolution and emphasized:

Municipalities and developers typically provide school land via Area Structure Plans.

The importance of cross-ministerial collaboration and municipal advocacy was noted.

# Pre-K Program Update at 10:30 a.m.

Associate Superintendent Student Services M. Perdue and Division Principal M. McEwen attended the meeting to present the annual Pre-Kindergarten Program update.

Diversification: 33% of students with moderate language delays improved to average levels after attending division pre-K.

Enrollment: Program growth noted at Ross Ford and École Olds Elementary. Community placement and EAL student access are increasing.

Cost: \$100,000 per class, including EA support, therapy assistants, and SLP/OT.

Funding: New funding model combines prior grant "bags" and allows more flexibility in allocation.

Medically Fragile Students: Division Office provides \$750,000 from the internal budget for supports post-PUF eligibility.

Cross-Community Planning: Division tracks student origins and early identification gaps to guide future program placements.

Partnerships: Exploring MOUs with community preschools to support students not in division pre-K sites.
